In view of the schedule fixed on 30.07.2025 the Ld. PP is present with three witnesses namely Rajen Lohar, Ranjan Sarkar and Ashit Paul.

The accused Golam Md. And Najish Ahesan are produced through VC Mode.

The rest seven accused namely Sahadat Reza, Sardar Ahammed, Noor Alam, Sahid, Tousif Reza, Sah Alam and Saklin Mustaq are present through their Ld. Advocate Jakir Hussain, Madhurima Das and Jalaluddin.

The witnesses are examined as PW-22 to PW-24 and discharged. All the witnesses are the seizure witnesses working at Shanti Shasthalaya and Anushandhan Kendra, Siliguri and the marked the seizure list dated 01.03.2023 as Exhibits 17 series. They identified the seized bullets produced in a container as Mat Exhibits-XI.

The witness schedule is exhausted and considering the ensuing Puja Vacation, the next schedule for evidence is fixed on 12.11.2025 to 14.11.2025.

The prosecution is directed to issue summons accordingly.

Accused are to be and as before and must be produced physically on the next date.

The charge alteration petition will be disposed in presence of the accused from custody.

The Ld. Advocate for Tousif Reza files a petition on 20.06.2025 regarding de-freeze his Current Bank Account **A/C 38719684063 (IFS Code SBIN0007713) in the name of Reza Builders at SBI Lodhan Branch (Branch Code 07713)** at District Uttar Dinajpur.

It is alleged that the accused was granted bail by the Order of Hon'ble Court but found his account at Lodhan Branch of SBI was frozen by the order of the police Goalpokher PS.

From the I.C. Goalpokher PS submitted a strong objection regarding de-freezing of the said account for some imaginary reasons.

It is not a case of Economic Offence Act nor there is any recovery from dacoity or the amounts deposited are out of any forgery. It is the right of the depositor to use his account as per his personal requirement and any Nationalized Bank cannot seize the account on his whims.

Hence, considering the xerox copy of cancel Cheque being no. 627985 and the documents submitted by the petitioner's advocate and considering the financial need of the petitioner during the festive period, the petition of Tousif Reza is hereby allowed.

The Manager, SBI Lodhan Branch, Uttar Dinajpur is hereby directed to permit the account holder to operate his account being no. **A/C 38719684063 (IFS Code SBIN0007713) in the name of Reza Builders at SBI Lodhan Branch (Branch Code 07713)** as per the banking rules and guidelines.

The I.C. Goalpokher PS is directed to appear personally by seven days of this Order to explain his authority to direct the bank for de-freezing the account being no. **A/C 38719684063 (IFS Code SBIN0007713) in the name of Reza Builders at SBI Lodhan Branch (Branch Code 07713)** before this Court.

Let a copy of this order be forwarded to the Manager, SBI, Lodhan Branch, (Branch Code 07713) Uttar Dinajpur and I.C. of Goalpokher PS accordingly.
