Today is fixed for hearing charge alteration petition filed by the prosecution on 04.09.2025.

The accused Golam Md. and Md. Naziz Ahsan are produced from Islampur Sub-Correctional Home.

The rest seven accused persons on CB, are present on dock.

The petition for alteration of charge is taken up for hearing.

Ld. PP argued that one of the injured victims namely, Habiba died after framing of charge and subsequently a supplementary charge sheet being No. 04 of 2024 dated 27.06.2024 has been submitted.

The Ld. Advocate on behalf of the accused persons gave their consent regarding alteration of charge in respect of victim Habiba and the original charge dated 20.05.2024 is hereby altered in fourth column and in fifth column. In the fifth column of charge the name of Habiba is added with Arif.

The fresh alteration charge is read over and explained to the accused persons by which they claimed innocent and agreed for trial before this court.

The accused are examined individually and the fresh charge form is accordingly placed in the record.
