ORDER

1. Bail application put up before me being Duty Magistrate as learned Presiding Officer is availing summer vacations.
2. This order of mine shall dispose of regular bail application moved by the applicant/accused *Gurwinder Singh*.
3. The facts of the FIR is that on 23.03.2026, when ASI/SHO Pargat Singh along-with other police officials were present at T Point Satir Wala in connection with checking of bag elements then, he received

a secret information as to that two vehicles on the phirni of Village Jandwala out of which one vehicle is of black colour and another is car make Zen, colour silver and person present in both the cars are cross firing on each other with intention to kill each other. If naka is held, then they can be apprehended along-with weapon. Considering the information being reliable, FIR under Sections 109 BNS and 25/54/59 of Arms Act was registered.

Thereafter, Jagmeet Singh and Vicky co-accused were arrested on 24.03.2026 and along-with them accused Davinder Singh and Gurwinder Singh were also nominated and from the other side who cross fired Dhana Singh son of Bakhshish Singh, Navdeep Singh alias China and Billa son of unknown and 2-3 unidentified persons with MG Hactor Vehicle were nominated.

4. It is because of this reason that accused Gurwinder Singh is in custody since 01.04.2026.

5. Upon notice, Sh. Vinod Kumar, learned APP for the State appeared, but he has not filed the reply to the present application and he has orally opposed the present bail application.

6. I have heard learned counsel for the applicant, learned Additional PP for the State and have gone through the file carefully with their able assistance.

7. The accused had earlier filed bail application in this case which was allowed vide order dated 02.06.2026. However offence U/s

194(2) BNS was not mentioned in bail application and consequential in bail order. Since accused has been granted in main offences also, present bail application is allowed on same terms and conditions as per order dated 02.06.2026. Papers be attached with the present bail application.

8. Application stands disposed of. Ahlmad is directed to send the copy of this order through email forthwith to the concerned Jail, where the applicant is confined. Bail application be sent to concerned Court immediately for the purpose of consignment.
