1)	That this Interlocutory Application is allowed.
2)	That the petitioner is permitted to amend the plaint by inserting the words "and subsequent years" immediately after the phrase "2023-2024" occurring in the fourth line of the second paragraph and fifth line of the third paragraph of the prayer portion of the plaint.
3)	That the amended plaint shall be filed within seven days from the date of receipt of this order after carrying out the necessary corrections.

4)	That the respondents are at liberty to file additional written statement, if any, confined to the amended pleadings within the time prescribed by law.
5)	That the 6th Respondent is at liberty to file an additional written statement, if any, strictly confined to the amended portion, within 14 days thereafter.
6)	Both parties are directed to strictly cooperate for the expeditious trial of the suit to ensure compliance with the time limit stipulated by the Hon'ble High Court in W.P.(MD) No. 24096 of 2025.
7)	No order as to costs.
