ORDER

1. Applicant has sought anticipatory bail under section 438 Cr.P.C. on the ground that he has been falsely implicated in this case on the confessional statement of co-accused and applicant is ready to join the investigation by cooperating the police and prayed for bail.

2. Notice of the bail application was given to the Additional PP for the State who appeared on behalf of the State and opposed the bail application.

3. Police record was called which has been received and perused.

4. Heard. Considered. In this case as per FIR dated 05.06.2021 it has been alleged that during patrolling duty in the area of village Kotli

Surat Malhi near Govt. School one younger boy was seen by the police on foot and who on the basis of suspicion was apprehended and he disclosed his name Robin Masih. From non applicant Robin Masih 5 gms Heroin was recovered which was taken into police possession. During interrogation non applicant Robin Masih confessed that 02 gms Heroin was procured by him from Raj Masih @ Billa and 03 gms Heroin was procured by him from applicant Deep son of Piara Lal resident of village Rauwal. Accordingly vide GD No.50 dated 05.06.2021 applicant has been nominated in this case by adding the offence under section 29 of NDPS Act.

5. Recovery involved in this case 05 gms Heroin is minor more than small quantity. Applicant is ready to join the investigation by cooperating the police. At this stage, applicant is ready to join the investigation by cooperating the police with the Arresting Officer till 14.07.2021 and on doing so, the Arresting Officer shall release him on interim anticipatory bail subject to the conditions laid down under section 438(2) Cr. P.C. to its satisfaction. Now to come up on 14.07.2021 for consideration on bail application on merits and police record be also produced on the date fixed.
