ORDER :

This order of mine shall dispose of application under Section 438 of Criminal Procedure Code, moved by applicant/accused aforesaid, seeking pre-arrest concession.

2. Shri B. S. Riar, advocate, learned counsel for applicant/accused has argued that applicant/accused was found innocent during investigation and he has now been summoned under Section 319 of Criminal Procedure Code. He has thus urged that applicant be released on anticipatory bail.

3. Mrs. Mandeep Kaur, learned Additional Public Prosecutor has opposed the bail application on the ground of gravity of offence.

4. I have given thought consideration to contention raised before

me and have perused record carefully.

5. It is found from record that applicant/accused was not originally challaned, rather, he has been summoned under Sec. 319 of Criminal Procedure Code, vide order dated 15.7.2019. He is not required for the purpose of custodial interrogation, as investigation is already complete and matter is pending before this court. No useful purpose would be served by sending him to prison at that stage. In these facts and circumstances, without commenting on merits of case, application in hand is allowed. Applicant/accused is ordered to be released on bail on furnishing bail bonds in the sum of Rs. 30,000/- with one surety in the like amount to satisfaction of this court. He will undertake to appear before Court on each and every date of hearing; he will not leave country without prior permission of court and that he will not influence any person acquainted with present case pending against him.
