

Rohit Kumar @ Ashu versus State of Punjab

ORDER

1. This order of mine shall dispose of second application filed by applicant/accused Rohit Kumar @ Ashu son of Rakesh Kumar resident of H.No.701, Mohalla Shukarpura, Damop Wali Gali, P.S. Civil Lines Batala, Tehsil Batala District Gurdaspur, under Section 483 of BNSS for regular bail.

2. Brief facts of the case are that FIR No. 322 dated 25.12.2025 under Sections 125 of BNS and Sections 25, 27 of Arms Act (offences under Sections 111 and 341 (2) were added and offence under Section 27 of Arms Act was deleted vide DDR No. 31 dated 29.12.2025) was registered at Police Station City Gurdaspur on the basis of statement of Amandeep Singh son of Des Raj, resident Kothe Ghurala, P.S. Tibber, District Gurdaspur, who got recorded his version before the police authorities that he is resident of above said address and working in Aujia Hub Immigration in PUDA Market Jail Road, Gurdaspur. On 25.12.2025, he was present in the office along with Rojji Bala and Anurag Sharma. Their Immigration Centre is located in the basement of the building. Rojji Bala was sitting on reception seat in front of stairs. He along with Anurag Sharma was sitting on the side of reception. One haircut young person came present in the Centre and asked Rojji Bala about the owner of Centre. Rojji Bala responded that he has gone abroad. That young man said that Nishan Paji has sent him and thereafter, he left the Centre. That young man again came after sometime, and at that time, he was holding pistol. He fired two gunshots in the air and thereafter, he fled away. On checking CCTV, they saw that one another accused was outside the Centre on motorcycle and thereafter, they both fled away.

3. Learned Additional Public Prosecutor has put in appearance on behalf of State. SI Som Lal No. 775/GSP Police Station City Gurdaspur produced police record and his statement has recorded regarding stage of investigation.

4. Allegations against the applicant/accused Rohit Kumar @ Ashu are that complainant Amandeep Singh son of Des Raj, resident Kothe Ghurala, P.S. Tibber, District Gurdaspur got recorded his version before the police authorities that he is resident of above said address and working in Aujia Hub Immigration in PUDA Market Jail Road, Gurdaspur, and on 25.12.2025, he was present in the office along with Rojji Bala and Anurag Sharma. He further asserted that their Immigration Centre is located in the basement of the building and two young men came there and fired gunshots in the air and thereafter fled away. Applicant/accused Rohit Kumar @ Ashu was nominated in this case on the basis of secret information and thereafter, applicant/accused was arrested on 29.12.2025. It is pertinent to mention here that this is second bail application of applicant/accused and his first bail application was dismissed vide order dated 09.02.2026. Though it is argued that circumstances have been changed as investigating agency has presented its report before the Ilaqa Magistrate after completion of investigation, but at the same time other facts cannot be ignored. Deadly weapon has been used in this case. Sections 125, 111, 341 (2) of BNS and 25 of Arms Act have been attracted in this case. Perusal of police record shows that some accused involved in this case have not been arrested so far. Possibility cannot be ruled out that applicant/accused can influence the prosecution witnesses if being released at this stage. In view of circumstances, application is dismissed being without merits. Police record be returned and bail application file be consigned to the record room.
