Today is fixed for production of the accused persons and consideration of charge and awaiting report from All Women P.S KGP.

No report is received as yet from All Women P.S KGP.

The accused persons are produced before this Court and remanded to J/C till 20.11.2021.

Ld. Special P.P and Ld. Defence Counsels are present.

Ld. Counsel files a petition on behalf of Mithu Roy @ Rubina Bibi praying for bail petition and also files a petition for adjournment for consideration of charge.

Heard all sides.

Considered.

The prayer for adjournment is considered and allowed.

The bail petition is taken up for hearing.

Ld. Advocate for the accused / petitioner submits that the female accused person is the mother of the victim girl and she has been falsely implicated in this case . He is the permanent resident within the jurisdiction of this Court. There is no chance of her absconding and accordingly he prays for bail in any terms and condition.

Ld. Special P.P raises strong objection.

Heard both sides.

On perusal of the case diary and records, it transpires that the accused /petitioner is the mother of the victim girl. There are sufficient incriminating materials against the accused/petitioner. The victim girl is only 15 years old. Moreover, the female accused/petitioner is apprehended on the direction of Hon'ble High Court at Calcutta passed in C.R.M No.1525/2021.

In view of the above and considering the facts and circumstances as well as materials on record, this Court is not inclined to release him on bail at this stage. Hence, the prayer for bail is considered and rejected.

One petition is filed on behalf of the petitioner Minati Majhi, the grand-mother of the victim girl (who is in Vidhyasagar Balika Bhaban) on the ground stated therein.

Copy served.

The prayer of visitation of the minor victim Anamika Ray is taken up for hearing.

The Ld. Counsel appearing on behalf of one Minati Majhi submits that the applicant is the grandmother of the victim and her mother Mithu Roy is in custody. The petitioner /grand-mother wants to meet the victim at the Home. The petitioner files the photocopy of her voter's identity card (original shown and returned back) and prays for visitation of the minor victim Anamika Ray .

It appears from the case record that the victim Anamika Ray herself lodged a complaint on 29.03.2019 and she is presently staying at Vidyasagar Balika Bhaban as a minor victim. After carefully perusing the case record vis a vis prayer of the petitioner the same is considered and allowed.

The Superintendent Vidyasagar Balika Bhaban, Paschim Medinipur is directed to allow the minor victim Anamika Ray , daughter of Ashim Ray of village Khairullahchak to meet Minati Majhi on **11.10.2021** in due compliance with necessary formalities.

The petitioner is directed to produce her identity proof i.e Votar Card, Adhar Card before the Office of the Superintendent, Vidyasagar Balika Bhaban, Paschim Medinipur.
