This is an Inventory Proceedings filed upon the death of Late Joaquim Miranda and Late Jose Miranda, hailing from H. No. 35/B, Tolleaband, Davorlim, Salcete, Goa.

2. The Proceedings are filed by the Applicant, who is the granddaughter of the deceased for Declaration under Section 373 (b) of The Goa Succession, Special Notaries and Inventory Act, 2012. By Order dated 14.11.2022, Applicant namely Mrs. Dannia Miranda was appointed as the Head of the Family.
