MEDIATION REFERRAL ORDER

Petitioner filed a petition praying for time. Subsequently the time petition is not pressed by the Ld. Counsel for the petitioner.

O.P. filed hazira through Ld. Advocate.

Heard the Ld. Advocate for both sides.

In the case, the applicants are praying for appointing them as guardian of the person and property of the minor- Ratnadeep Singh. Submission of the Ld. Counsels of the parties disclosed the element of settlement between the parties.

So, in pursuance of the provisions u/sec. 89 of the Civil Procedure Code, and the Civil Procedure Mediation Rules, 2006, the parties are directed to appear before the Ld. Mediator, at ADR Building, DLSA, Paschim Medinipur on 22.11.2023 at 2.00 P.M. If it is not possible for the Mediation Centre to mediate on the date fixed, it shall arrange a future date for mediation convenient to the parties.

As per the provisions of Rule 4 (a)(iv) of the Civil Procedure Mediation Rules, 2006, Sri Anupam Sarkar, Registrar, Civil Courts, Paschim Medinipur, an officer in the rank of the Civil Judge (Senior Division), in the West Bengal Judicial Service is appointed as Mediator in the case.

The Ld. Mediator shall be paid honorarium of Rs. 3000/- on settlement of the case as per Rule 26A of the Mediation Rules, 2006.

If a settlement is reached it shall be returned back to this Court with the terms of settlement recorded by the Judge Mediator and signed by the parties/power of attorney holder/Counsel for further appropriate proceeding /order.

If no settlement is reached, or the case is not considered to be suitable for being settled through Mediation it shall be returned to the Court without any comment or record of the proceeding undertaken.
