On 24.04.2022 ,I.O submitted an application before the Ld. C.J.M, Paschim Medinipur praying for five days police remand and prayer for medico legal examinatio report of accused Sk. Anowar @ Sk Anower.

The I.O of the instant case S.I Chandidas Mukharjee prays for 05(five) days police remand of the accused Sk Anowar @ Sk Anower on the ground stated therein.

Seen, let it be kept with the case record.

The prayer of police remand is taken up for hearing.

I.O namely S.I Chandi Das Mukharjee is present before the court and submits that 05 (five) days police remand of the accused person Sk Anowar @ Sk. Anower is required to verify the P.O, reconstruct the criminal scene, more interrogation to know his actual motive.

Perused the case record, case diary and the prayer for police remand and on perusal of the same police remand is **allowed for (03) days**.

The I.O. S.I Chandidas Mukharjee is directed to abide by the guidelines of the Hon'ble Apex Court and provide medical assistance to the accused person as and when required during police remanded.

Considering the facts and circumstances of the instant case the prayer of I.O is considered and allowed.

The Superintendent, Medinipur Medical College and Hospital, (HOD, FSM of M.M.C.& Hospital) Paschim Medinipur is directed to take steps for medico legal examination of the accused namely Sk Anowar @ Sk Anower subject to consent of the accused person.

The I.O namely, S.I Chandidas Mukharjee is hereby directed to produced the accused person before the HOD, FSM of M.M.C.& Hospital Paschim Medinipur for his medical examination.

Send copy of this order to the I.O, and Medinipur Medical College and Hospital, (HOD, FSM of M.M.C.& Hospital) Paschim Medinipur compliance at once.

The I.O of the instant case S.I. Chandidas Mukharjee files an application praying for recording statement of complainant namely Saina Bibi u/s 164 Cr.P.C

Ld. Special Public Prosecutor Soumini Maity is present.

I have checked the voluntariness of complainant for giving statement before the Learned Magistrate.

I have perused the petition of I.O for recording statement of complainant u/s-164 of Cr.P.C and found that for the interest of investigation it required to be allowed.
