Accused Srimanta Hansda, Kishan Murmu @ Debo and Biswajit Hembram @ Ratha are produced from judicial custody.

Accused Bijoy Murmu (21 years) is brought under arrest on the strength of warrant issued by this Court along with memo of arrest and inspection memo.

Accused Bijoy Murmu has filed a bail petition along with vokatnama.

Bail petitions filed by the accused persons, Srimanta Hansda, Kishan Murmu @ Debo and Biswajit Hembram @ Ratha.

None of the accused persons moved the bail petitions.

Investigating Officer has submitted a prayer to re-open the case to conduct further investigation and prayed for police custody of the accused, Bijoy Murmu and medico-legal examination of the accused.

The prayer for police custody of the accused is taken up for hearing.

Learned Defence Counsel and Ld. Special Public Prosecutor are present.

Investigating Officer is present.

Heard both sides.

Learned Defence Counsel submits that 5 days P.C. is not required for the purpose as stated by the Investigating Officer.

Learned Special Public Prosecutor submits that reasonable time may be allowed to complete the further investigation.

After hearing both sides and considering the case diary, this Court is of the view that the accusation against the accused is well founded and at least four (4) days police custody is required to complete the investigation. Therefore, the prayer for police custody is allowed. Accused, **Bijoy Murmu (21 years) is remanded to Police Custody for four (4) days.** Investigating Officer is directed to observe the guidelines issued in the case of D.K. Basu versus State of West Bengal and guidelines of National Human Rights Commission regarding police custody. Investigating Officer is directed not to make any kind of torture upon the accused during police custody and provide him medical aid if required and produce him before this Court on **24.06.2024** with medical examination report and case diary.

The prayer for medico-legal examination of the accused is allowed after hearing both sides.

The Superintendent of the Medinipur Medical College and Hospital is requested to conduct the medical examination of the accused, **Bijoy Murmu** by any competent doctor.

Other accused persons are remanded to J.C. till next date.

Fix **24.06.2024** for production of the accused, Bijoy Murmu from P.C and production of other accused persons from J.C.
