Investigating Officer, S.I. Rajesh Chandra Kar of Dantan P.S. has filed an application praying for passing necessary order for drawing sample and certification of seized contraband (ganja) articles under sub section 52 (A) of NDPS Act from seized ganja. The application is regd. as **IA/1/2021.**

Prayer is considered and allowed.

Let the case record be sent to the Judicial Magistrate, 3rd Court, Paschim Medinipur, on proper receipt for :

(a) certifying the correctness of the inventory;

(b) taking photographs of substances or conveyances in his presence and certifying such photographs as true; and

(c) allowing to draw representative samples of such substances, in his presence and certifying the correctness of any list of samples so drawn.

I.O is directed to provide all necessary assistance to the Ld. Judicial Magistrate, 3rd Court, Paschim Medinipur, in this regard.
