Today is the date fixed for production of the accused person from M.C.C.H, Paschim Medinipur, and supply of the documents relied upon by the prosecution.

Accused is produced from M.C.C.H, Paschim Medinipur.

One bail petition u/s 439 of the Cr.P.C is filed on behalf of the accused person Laxmikanta Khilari @ Baka.

Ld. Advocate for the accused person is present.

Ld. Special Public Prosecutor Sri Swarnendu Parial is present.

Ld. Advocate for the accused person has submitted that in this case this chargesheet has already been filed, and accused person is in custody since 18.10.2019 . He prayed for bail of this accused person on any condition.

Ld. Special Public Prosecutor has vehemently opposed the bail prayer of the accused person. He has submitted that there is serious allegation against this accused person, and in case of enlarging this accused person on bail, there is chances of influencing the witnesses of this case. He prayed for rejection of the bail petition filed on behalf of accused person.

I have heard the submissions of the Ld. Advocate for the accused person, and the Ld. Special Public Prosecutor of this case, and perused the case diary.

This accused person is in custody since 18.10.2019, and charge-sheet in this case has already been filed, and this accused person is local resident. I have of view that this accused person may be enlarged on bail subject to fulfillment of the following conditions.

1. This accused person will not influence the witnesses of this case.
2. This accused person will appear each and every date of this case except in extraordinary situations supported by cogent documents.
3. In case of breach of any of these conditions, this bail will automatically cancelled.

This accused person may be enlarged on bail on furnishing bail bond of sum of Rs. 2000/- with two registered sureties of same amount subject to satisfaction of the Ld. C.J.M, Paschim Medinipur.

Copies of all the documents in 49 pages handed over to the accused person in presence of his Ld. Advocate.
