This petition came before me on 24.11.2022 for final hearing in the presence of Smt. R.Krishna Kumari, Advocate for petitioner/accused and of Sri N.Kalidas Reddy, learned Special Public Prosecutor for Respondent/Complainant and the matter having stood over for consideration till this day, this Court made the following:

ORDER

1. This is an application filed by the petitioner/accused under Rule 188 of Criminal Rules of Practice praying the court to return the F.D.R. amount of Rs.40,000/- to him in the circumstances stated by him in detail in the application.

2. Heard both sides. Perused the record.

3. In the circumstances the present application is filed by petitioner/accused under Rule 188 of Criminal Rules of Practice praying the court to return the F.D.R. amount of Rs.40,000/- which was deposited by him towards security while he was releasing from jail. The main case was tried and he was acquitted as per judgment of this court dt.28.12.2021. No appeal is either preferred nor pending before the Hon'ble High Court of Andhra Pradesh. When notice is given to the learned Special Public Prosecutor, he did not state any objection for return of FDR amount of Rs.40,000/-. Hence this court is satisfied to return the FDR amount of Rs.40,000/- with accrued interest to the petitioner.

4. *IN THE RESULT,*

this application is allowed and return the FDR amount of Rs.40,000/- with accrued interest to the petitioner under proper acknowledgment.
