Today is fixed for E/R of Warrant of Arrest and appearance.

The accused persons , namely, Hyder Mondal and Gouranga Lashkar on Court bail have not appeared in Court. Both of them have prayed for adjournment. Their prayer is considered and allowed.

On scrutiny of record it appears that Inspector-in-Charge, Chakdaha Police Station has been directed on several occasions for executing the Warrant of Arrest against Jamshed Nasir Mondal.

The record shows that Warrant of Arrest against Jamshed Nasir Mondal is pending since 2021. He is absconding since the last four years. Vide Memo No. 117 dated 17.03.2021 Warrant of Arrest has been issued against Jamshed Nasir Mondal. Reminder was issued from this Court on several occasions.

Vide Memo No. 150 dated 23.02.2022 , Memo No. 323 dated 12.05.2022, Memo No. 646 dated 22.08.2022, Memo No. 408 dated 28.06.2023 Memo No. 220 dated 19.03.2024 this Court sent copies of orders to Inspector-in-Charge, Chakdaha Police Station thereby directing to execute Warrant of Arrest against Jamshed Nasir Mondal. Till today the orders are not complied with. No report is sent from Chakdaha Police Station explaining the reason of non- compliance with the orders referred above.

In the circumstances, Inspector-in-Charge, Chakdaha Police Station is further directed to execute the Warrant of Arrest issued against **Jamshed Nasir Mondal s/o Aminul Haque Mondal of Narapatipara , Simurali, Police Station Chakdaha, District- Nadia and produce him before the Court by 30.07.2024 failing which appropriate proceeding shall be initiated for non- compliance with the orders.**

Inspector-in-Charge, Chakdaha Police Station is further directed to treat the matter as extremely urgent as there is direction of Hon'ble Supreme Court for expeditious hearing of this case.
