ORDER:

1. Record received. Heard. It is mentioned in the instant bail application that accused/applicant is innocent and has not committed the alleged offence and he has been falsely implicated in the present case by the police of P.S.Dirba. It is further averred that applicant is not required any kind of investigation nor any kind of custodial interrogation is required. It is further averred that there is no criminal case pending against him. It is further averred that applicant is ready to join the

investigation as and when required by the police or as directed by the court. Hence, it is prayed that the bail application may be allowed.

2. Learned counsel for the accused/applicant while arguing in the lines of bail application contended that same may be allowed.

3. Conversely, learned Addl. Public Prosecutor for the State contended that there are serious allegations against the accused/applicant and therefore, bail application may be dismissed.

4. After hearing rival submissions, it has transpired that instant case FIR was registered on receiving the letter from Assistant Executive Engineer against Kaur Singh and Jaskaran Singh son of Kaur Singh on the allegations that they shifted the electric connection and tampered with the articles belonging to electricity department. As per allegations, accused shifted the electric connection bearing APNo.28/1465 3007441218, load 20BHP without depositing the process fee or approval of the department.

5. Record reveals that there was no serious allegation against accused/applicant of causing harm to any government official or using any criminal force and who rather allegedly infringed rules while unauthorisedly shifting electric connection and in such situation, custodial interrogation of accused/applicant does not seem necessitated and therefore without commenting upon the merits of the case, accused/applicant is directed to join investigation on or before

16.07.2025 and in case of his appearance before the investigating officer/Arresting officer concerned to join the investigation in this case, the investigating officer/ Arresting officer of concerned shall release him on interim bail to his/her satisfaction, subject to the following conditions:-

- a) Applicant/accused shall make himself available for interrogation by a police officer as and when required;
- (b) Applicant/accused shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him/her from disclosing such facts to the Court or to any police officer;
- (c) Applicants/accused shall not leave the country without prior permission of the Court.

6. A copy of this order be sent to the SHO, **Police Station Dirba**. Now to come up on 16.07.2025 for awaiting report of Investigating Officer.
