Order

1. The instant application has been moved by the applicant for the registration of date of birth of the applicant in the concerned register. The applicant has stated that applicant is the resident of above mentioned address and his date of birth is 23.05.1998, the name of the mother of applicant is Sudha Abrol and father name is Anil Abrol Place of birth is at home at Ward no 4, but due to some domestic problem the date of birth could not be registered at Municipal council Reasi at that time he could not get it required and the same now required to be registered in the records. Hence this application in hand. The applicant has annexed a photocopy of his detail mark sheet and Aadhar card . An affidavit duly sworn in has also been attached herewith with along with a vakalatnama.
2. In view of the application report from the concerned Municipal Council was sought. The report suggested that the date of birth of the applicant was not registered with them in his register of Births and Deaths.
3. In order to invite objections from general public, a proclamation to this effect was published in newspaper Early times dated 18/11/2022. Despite the publication no one appeared in the court to file any objections within the stipulated time in the publication.
4. In support of application, the applicant has produced evidence in the form of his own statement which stands recorded in the court along with the

statement of the witness namely Sudha Abrol W/o Anil Abrol R/o Ward no 4, Tehsil and District Reasi who is the mother of the applicant and Abhishek Sharma S/o Joginder Kumar R/o Ward no 4 Tehsil and District Reasi. The witness has deposed in the support of applicant's contention. The statement of the applicant and the witnesses stands duly recorded and made part of the file.

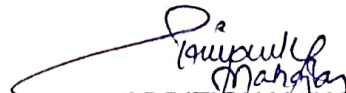

From the deposition of applicant and other witnesses in the support of applicant, the date of birth of the applicant was sufficiently proved but due to the reason mentioned above the same could not be entered in the Municipal records. There is nothing on record to reject the contentions of the application of the applicant. Thus there is no hitch in passing the direction for recording the birth particulars of the applicant as such : -

6. As such E.O Municipal Council Reasi is directed to record the date of birth particulars of applicant as mentioned above in his official records. Office is directed to furnish a copy of this order to E.O Municipal Council, Reasi concerned for its compliance under the rules.
7. This direction, is, however binding on the non-applicant E.O Municipal Council, Reasi only and does not confer any citizenship right or state Subject entitlement or to any compensation to the applicant.
8. Application accordingly is disposed of and consigned records after its due compilation under the rules.
