Heard both sides at length.

Perusing the case record, case diary and considering the materials on record and vis -a-vis in the C.D , I am of opinion that there are prima facie materials against the accused persons to frame charge U/S U/S 3/4/5 of Explosive Substance Act.

The charge is accordingly framed against the accused person **U/Sec. 3/4/5 of Explosive Substance Act**. The contents of the charge is read over and explained to the accused person in Bengali to which the accused person plead 'not guilty' and claim to be tried.

Ld. P.P-in-charge is directed to file requisites at once to ensure arrival of seized articles on date fixed.

Issue summons to the witnesses accordingly.
