**ORDER BELOW EXH.1**( Delivered on this 19<sup>th</sup> day of June, 2026)

1] This is an application for bail u/s. 483 of Cr.P.C. in C.R.No. 105/2026 registered with Bhore Police Station against the applicant for the offences under Sec. 137(2) of BNS along with Sec. 8, 12 of The Protection of Children from Sexual Offences Act, 2012 (POCSO).

2] The prosecution's case in short, is as under :-

Allegations against the applicant in FIR are on 10/05/2026 at about 12.30 pm applicant entices a minor girl age 15 years and took her out of lawful guardianship of the complainant. Therefore complainant lodge complaint in Bhore police station. On the basis of complaint Bhore police station registered FIR bearing No. 105/2026 u/sec. 137(2) of BNS along with Sec. 8, 12 of The Protection of Children from Sexual Offences Act, 2012 (POCSO). Applicant is

arrested. Now he is in jail. Applicant approach this court for bail on the ground of innocence and false implication.

3] The investigating officer by filing say (Exh.5) has strongly opposed the application.

4] The victim by filing her say at Exh. 6 has strongly opposed the bail application.

5] Heard Ld. Advocate for applicant, Ld. A.P.P. Ms. Jadhav for the state. I have considered the submissions advanced by the advocates for respective parties.

6] From the above following points arise for my determination and I have recorded my findings thereon for the reasons stated below :

### **REASONS**

7] The allegations against the applicant are that he took the victim girl out of guardianship of the complainant entices her. Those allegations are serious in nature. It appears from record that applicant is behind bar since 11/05/2026. Investigation is going on. Nothing is to be recovered from him. He is ready to abide the terms and

conditions of the court. His further detention behind bar is not necessary. The Ld. APP raised apprehension that there is possibility of threatening the victim and witnesses by the accused. However, this apprehension expressed by the prosecution can be minimized by imposing stringent condition. Therefore, in my view, it is a fit case to release the applicant on bail by imposing stringent conditions. Hence, the following order :

**ORDER**

1. Bail Application No.2685/2026 is allowed.
2. Applicant / accused - Sanket @ Aniket Santosh Dhanavale, age 20 years, residing at Dhanavali, Tq. Bhore, Dist. Pune is released on bail on furnishing P.R. bond of Rs.15,000/- with one surety in like amount in C.R.No. 105/2026 registered with Bhore Police Station on following conditions :
  - a] The applicant shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the court.
  - b] The applicant shall no way establish any contact with the victim girl and witnesses either on telephone or any actual contact and shall not enter in the vicinity of the house of victim till conclusion of trial.
  - c] The applicant shall at the time of execution of bond, furnish his address and telephone/mobile number(s) to the Court and shall keep it updated.
  - d] The applicant shall attend Bhore police station on every

Monday from 10.00 a.m. to 12.00 noon until filing of charge-sheet and thereafter he shall attend the court dates regularly.

e] The applicant shall not commit an offence similar to the offence for which he is accused or suspected.

f] In case of breach of any of the conditions or occurrence of any single incidence with the victim girl by the applicant, prosecution is at liberty to file application for cancellation of bail.
