

Act VIII 19 of 2018

Order No. 32 dtd 10.4.2023.

Today is fixed for further hearing of the instant case.

Petitioner filed hazira. O.P./Rupsana Begam filed hazira.

Petitioner is present with his Ld. Advocate. O.P/mother is present with her daughter and her Ld. Advocate.

The petition dated 31.05.2022 is taken up for hearing.

In the said petition the petitioner prayed for modification of the order dated 28.02.2022 passed by this Court. Ld. Advocate for the petitioner submits that the O.P. is not attending the office of the DLSA in time with her minor daughter. He further submits that the petitioner is not reluctant to attend the office of the DLSA within the time specified by this Court. He further submitted that the petitioner has no intention to harass the O.P. and her minor daughter.

Ld. Advocate for the O.P. submits that the petitioner is not attending the office of the DLSA within the time specified by this Court. He further submits that the petitioner visited the office of the DLSA along with his friends and they laughed at the O.P. and used to pass defamatory comments towards the O.P. which is painful for the O.P. Ld. Advocate for the O.P. submitted that the petitioner has been trying to harass the O.P. and her minor daughter. He further submits that the petitioner used to hug the minor child awkwardly during his visit at the office of DLSA. He further submits that the minor is a student of Class-V and her school starts from 6.50 a.m. and closes at 1.30 p.m. So, it is difficult for the minor to attend the office of the DLSA at 2.00 p.m. Accordingly, he prayed for modification of the order passed by this Court on 28.2.2022.

Perused the order passed by this Court on 28.2.2022.

On perusal of the record and upon hearing the counsel of both sides this Court is of the opinion that petitioner is permitted to meet with his minor daughter namely, Aniya Hossain once in a week i.e. on every Friday of each week in between 3.00 P.M. to 5.00 P.M. at the office of D.L.S.A., Paschim Medinipur until further order.

Accordingly the prayer for modification of the order passed by this Court on 28.2.2022 is allowed.

Both parties are directed to appear before the office of D.L.S.A., Paschim Medinipur once in a week i.e. on every Friday of each week in between 3.00 P.M. to 5.00 P.M.

The O.P. is directed to produce the minor daughter namely, Aniya Hossain before the Office of D.L.S.A., Paschim Medinipur in between 3.00 P.M. to 5.00 P.M. on the aforesaid dates.

Inform both parties.

Ld. Advocate of both sides are also directed to be present on the date fixed.

Fix 05.6.2023 for further hearing of the case.

Both parties are directed to put their signatures before the Secretary, D.L.S.A., Paschim Medinipur in the register maintained by the office of the D.L.S.A., Paschim Medinipur .

Secretary, D.L.S.A., Paschim Medinipur is hereby requested to secure the attendance of the petitioner and the O.P. along with her minor daughter namely, Aniya Hossain on each and every visitation.

Let a copy of this order be sent to the D.L.S.A., Paschim Medinipur for information and taking necessary action.
