Accused namely Nishant, Ritik, Sahil, Sagar, Vansh, Om Parkash, & Mannu produced before this Court in custody through VC.

2. Accused Dilbag appeared in pursuance of notice issued to him and filed an application for regular bail and for furnishing of bail bonds and surety bonds. However, it has come to the notice of this court that accused is on anticipatory baid from Hon’ble High Court and this court has not empowered to grant regular bail.

3. **Requisite bail bonds on behalf of accused Dilbag furnished, surety bonds accepted and attested.**

4. Endorsement shall be made on the documents produced by surety that he has taken the surety of accused in the present case. In compliance of judgment passed by the Hon’ble Punjab & Haryana High Court in case Civil Writ Petition No.4898 of 2018 titled as Hari Chand Vs. U.T. Chandigarh. An intimation be sent to the concerned authority regarding the documents of which have been furnished by the surety.

5. Copy of challan supplied to accused persons namely Ravi, Sudhir, Vikas, Arun, Rahul, Sachin, Siva, Nageena & Dilbag as well as Sh. Arvind Batra, LADC on behalf of accused namely Nishant, Ritik, Sahil, Sagar, Vansh, Om Parkash & Mannu free of costs as envisaged under section 230 of BNSS. Statement of accused persons as well as Sh. Arvind Batra, LADC to this effect recorded. Now case is adjourned to 13.07.2026 for checking of challan.

6. Till then accused persons namely Nishant, Ritik, Sahil, Sagar, Vansh, Om Parkash & Mannu be kept in judicial custody and be produced before the court on 29.06.2026 for **rehnumai** through VC.
