O R D E R

(Delivered on this 14th day of October of the year 2022)

1. This is an application filed to obtain a Certificate from this Court under Article 248 of the *Codigo de Registo Civil*, 1912.
2. The Applicant, being a Portuguese National, seeks to marry Miss. Anifa Cardozo, daughter of Mr. Conceicao Mariano Cardozo and Mrs. Telma Fernandes, spinster, aged 24 years, Indian National, residing at H. no. 58, Pateapur, Nuvem, Salcete, Goa - 403713.
3. The Applicant was born on 30.08.1994, at Margao, Goa, and is the holder of Portuguese Passport bearing no. CB208240.
4. The Applicant and Miss. Anifa Cardozo propose to register their marriage before the Civil Registrar of Salcete.
5. The Applicant being a Portuguese National and Miss. Anifa Cardozo being an Indian National, a Certificate from this Court is necessary for the Civil Registrar of Salcete to register their marriage under Article 248 of the *Codigo de Registo Civil*, 1912.
6. The Applicant has interalia produced his Birth Certificate, Portuguese Passport and OCI. He has also produced the Birth

Certificate and Residence Certificate of Miss. Anifa Cardozo, issued by the Village Panchayat of Nuvem.

7. On considering the present application, documents in support, the supporting affidavits produced by the Applicant and upon hearing Advocate Ms. Patsy Da Silva, based on the material on record, I am satisfied that there is no legal impediment to register the marriage of Applicant with Miss. Anifa Cardozo.

8. This Order shall be considered as a Certificate from this Court under Article 248 of the *Codigo de Registo Civil*, 1912 and may be presented before the Civil Registrar of Salcete, for the purpose of registration of the said marriage.
