Accused **Subrata Bera (25 years)** is produced from judicial custody. Accused files bail petition with power.

Accused Runu Rani Majhi surrendered and prayed for bail filing vokalatnama.

Accused Chandan Mandal @ Nimai and Susanta Bera on bail are present filing hazira.

Accused Anupama Bera and Trilochan Bera appear and prayed for bail with power.

No ER is received against Rabi Bera and Chhabi Bera.

Bail petitions of the accused Subrata Bera, Anupama Bera, Trilochan Bera and Runu Rani Majhi are taken up for hearing.

Learned defence counsel submits that the accused, Subrata Bera is in custody since 04.03.2025. There was an affair between the victim and the accused. She is more than 17 years. He is innocent. He has been falsely implicated in this case. Accused Anupama Bera, and Trilochan Bera have been granted anticipatory bail by the learned Sessions Judge in Criminal Misc. Case No. 4399/2024 dt. 23.08.2024 and Criminal Misc. Case No. 4712/2024 dt. 06.11.2024. There is no allegation of sexual assault against the accused Runu Rani Majhi. They may be granted bail imposing any terms and conditions.

Learned Special Public Prosecutor submits that the victim is pregnant due to the sexual assault committed by the accused, Subrata Bera. He did not raise objection against the bail prayer of other accused persons.

Due to the repeated sexual assault by the accused Subrata Bera, the victim was pregnant. Considering his involvement and gravity of the offence, his bail prayer is rejected. The accused is remanded to J.C. till next date.

The bail prayers of the accused Anupama Bera, Trilochan Bera and Runu Rani Majhi are allowed. They may furnish bail bonds of Rs.5,000/- each with two sureties of Rs.2,500/- each to the satisfaction of learned C.J.M. Paschim Medinipur. If they fail to furnish the bonds they shall be in custody till the next date. If they are on bail they shall not make any contact with the victim girl or any other witnesses of this case. If any complaint in this regard is received, their bail may be cancelled.

Fix **16.07.2025** for production of the accused Subrata Bera, appearance of the accused Chandan Mandal @ Nimai, Susanta Bera, appearance/production of the accused Anupama Bera, Trilochan Bera and Runu Rani Majhi and ER of WA against the accused Rabi Bera and Chhabi Bera. Recall WA against the accused, Runu Rani Majhi.
