Today is fixed for production and report in final form.

Sole accused, namely, Asish Kumar is produced from judicial custody.

Ld. Advocate for both sides are present.

A bail petition is filed for the accused person praying for his bail. Copy is served.

Ld. Advocate for the accused submits that the accused is in custody since 25.03.2026 and only 12.590 Kilograms of contraband 'Ganja' was recovered from his possession. Ld. Advocate further submits that statutory period of submitting the charge sheet has been over and I.O. has neither submitted the charge sheet nor prayed for extension of time for submitting the charge sheet. Hence he prays for bail of the accused on any condition.

Ld. P.P.-in-Charge leaves the matter to the discretion of this Court.

Heard both sides.

Perused the case record and other relevant documents.

On careful scrutiny of the case record it is found that this case has been registered u/s 20 (b)(ii)(B) of the N.D.P.S. Act with recovery of 12 Kilograms 590 grams of Ganja/Cannabis .The investigation began on 25.03.2026. The accused was brought under arrest on 25.03.2026. It means that the accused is in custody for 70 days. Till date, the charge-sheet has not been submitted nor there is any prayer u/s 36 A (4) N.D.P.S. Act seeking extension of investigation period. The statutory period for filing of charge-

sheet on completion of investigation has expired. Thus, the accused is entitled to default bail.

Considering such factual aspects, bail prayer of the accused person is hereby allowed.

The accused person, namely, Ashish Kumar be released on **bail of ₹. 40,000/-** with one registered surety of **₹ 10,000/-** and **another local surety of ₹ 30,000/-**, subject to satisfaction of Ld. Chief Judicial Magistrate, Paschim Medinipur, with condition to appear before the Court on each and every date, so fixed by the Court, in default, to judicial custody.

If on bail to **30.07.2026** for I.O's report and appearance of accused person .

Let a copy of the order be sent to the Ld. Chief Judicial Magistrate, Paschim Medinipur for information and taking necessary action.
