A status report has been filed by IO/SI Rocky. As per this report, mirror copy and examination report in respect of relied

upon video, which was so deposited in FIR No. 60/20, PS Dayalpur, are yet to be received from FSL. It is further reported that retrieved data from 13 mobile phones have been received from FSL and process of analysis of retrieved data is undergoing, which shall take at least two month's time because of voluminous data.

IO/SI Rocky and SHO submit that after analysis of the retrieved data from these mobile phones only, they shall be in position to take stand, if same to be relied upon in the present case or not and a supplementary chargesheet shall be filed accordingly as per outcome of analysis of this data.

In view of request made to grant further time for analysis of retrieved data from mobile phones and to receive mirror copy of relied upon video from FSL, case is adjourned for today. IO shall make endeavor to complete the process of analysis of retrieved data from the mobile phones and to take his stand, by next date of hearing. At the same time, fresh status of relied upon video shall also be obtained by IO and be informed to this court.

Verification report of bail bond as furnished for accused Imran (s/o. Sh. Nasreem Ahmed), has been received. As per report, bail bond has been verified and same is accepted.
