	21.12.2022	This miscellaneous criminal application for bail filed on behalf of accused/petitioner namely Pravesh Yadav @ Rampravesh Yadav, aged about 28 years, s/o Birendra Yadav, r/o village Postiya, P.S. Bashisthnagar, District Chatra who is in custody in connection with S.T. No. 317/2018, Bashisthnagar P.S. Case No. 10/2018, U/S 25(1A), 25 (1-B)a, 26 and 35 of Arms Act is being pressed today. Copy of the same has been served to the learned Addl. P.P. for the State. Learned lawyer on behalf of the accused/petitioner submitted that after cancellation of bail of the petitioner, he has filed a petition for issuing production warrant in the present case and after issuance of production warrant he has been remanded in the present case on 16.08.2021, and since then he is rotting in judicial custody. Thereafter no any petition for bail either anticipatory or regular has been filed or moved either before this court or before the Hon'ble High Court of Jharkhand, Ranchi. It is further added that the petitioner was

	Contd... 21.12.2022	on bail before cancellation of bail. Bail bond of the petitioner was cancelled on 20.11.2019 due to lack of communication regarding date of the case. Charges have been framed against the accused petitioner on 02.03.2022 and altogether five witnesses have been examined by the prosecution. It is further mentioned that process regarding examination of the prosecution witnesses have been issued, but since long no any prosecution witnesses have been produced by the prosecution, and hence there is no chance to produce any witnesses for his examination in near future. The petitioner is a poor labour and only earning member of his family and in his absence the whole family would be on starvation. He is a man of substance and he is ready to furnish sureties to the satisfaction of the Court. So lastly learned lawyer prayed that he be enlarged on bail. Learned Addl.P.P. appearing on behalf of the State submitted this is a case of misuse of privileged of bail by the petitioner, so he does not deserve bail. Having heard the rival submissions as well as from perusal of the case record it appears that this case was instituted U/S 25(1A), 25 (1-B)a, 26 and 35 of Arms Act on 28.01.2018 vide Bashisthnagar P.S. Case No. 10/2018 against

	Contd... 21.12.2022	this accused petitioner along with others on the basis of self statement of S.I. Shiv Gope, officer-in-charge of Bashisthnagar P.S. in which arms and ammunition were seized from the possession of the accused persons along with this petitioner. After investigation the charge sheet bearing no. 22/2018 dated 29.03.2018 U/S 25(1A), 25 (1-B)a, 26 and 35 of Arms Act was submitted against this accused petitioner along with others. Ld. CJM, Chatra took cognizance of the offences U/S 25(1A), 25 (1-B)a, 26 and 35 of Arms Act vide order dated 03.04.2018. Further Ld. CJM, Chatra after appearance of this petitioner committed the case before the court of Sessions vide order dated 06.11.2018. From perusal of the record, it appears that earlier the petitioner was granted bail by the Hon'ble Court in B.A. No. 5529/2018 dated 16.07.2018, and accordingly he released on bail on 24.07.2018. After commitment of the case during stage of hearing on the point of charge due to non-appearance of this petitioner his bail was cancelled on 20.11.2019 and N.B.W issued. Further on the basis of information given on behalf of this petitioner he has been remanded in this case on 16.08.2021. Charges have been framed against the petitioner and others on 02.03.2022 and altogether five witnesses have been examined by the

Therefore, in the light of above mentioned findings considering the period of judicial custody which is more than a year which in my view is more than sufficient for misusing the privileged of bail, I am inclined to enlarge the petitioner on bail. Accordingly, petitioner namely Pravesh Yadav @ Rampravesh Yadav is directed to be released on bail on furnishing bail bond of Rs. 10,000/- with two sureties of like amount each.
