Accused Sona Duari is produced from judicial custody.

A bail petition along with fresh vokalatnama is filed by the accused.

Accused Ranjit Duari and Munmun Duari have surrendered today filing vokalatnama and payed for bail filing bail petition. Recall WA against the accused persons.

Bail petition filed by the accused persons are taken up for hearing.

Learned defence counsel submits that the accused, Sona Duari is in custody since 22.11.2025. Charge sheet has been submitted in this case. There was an affair between the victim and the accused. The victim voluntarily went with the accused. He is innocent. He has been implicated in this case falsely. Considering his detention, he may be granted bail imposing any terms and conditions.

Learned defence counsel also submits that the accused Ranjit Duari and Munmun Duari are the parents of the principal accused. They are no way connected with the alleged offence. They are innocent. They may be granted bail imposing any terms and conditions.

Learned Special Public Prosecutor raises objection and submits that the victim is only 13 years old and the accused Sona Duari established physical relationship with her. She did not raise any objection against the bail petition in respect of the accused persons, namely, Ranjit Duari and Munmun Duari and submits that the victim did not implicate the accused persons in her statement.

Considering the age of the victim and the material in the case diary, this Court is not inclined to grant bail to the accused Sona Duari. Hence, his bail prayer is rejected. The accused is remanded to J.C. till next date.

Charge sheet has been submitted in this case. The accused persons, namely, Ranjit Duari and Munmun Duari are the parents of the principal accused. There is no allegation of sexual assault against the accused persons. Considering the facts and circumstances of this case and the materials in the case diary, this Court is inclined to grant them bail. Their bail prayer is allowed. The accused persons, namely, Ranjit Duari and Munmun Duari may furnish bail bond of Rs.2,000/- each with two sureties of Rs.1,000/- each to the satisfaction of learned C.J.M. Paschim Medinipur. If they fail to furnish the bonds they shall be in custody till next date. If they are on bail they shall not make any contact with the victim girl or any other witnesses of this case. If any complaint in this regard is received, their bail may be cancelled.

Copies are served to the accused persons.
