Case record is put up on the written prayer on behalf of accused person namely Lakhindar Paloi.

Accused person namely Lakhindar Paloi surrenders before this Court in person and filing another petition. Accused person namely Lakhindar Paloi is taken into custody and remanded to J/C. Recall W/A in respect of accused person namely Lakhindar Paloi.

Another application with fresh vakalatnama is filed on behalf of accused person namely Lakhindar Paloi praying for his bail. Copies of three petitions are served upon the prosecution.

Bail petition is taken up for hearing. Ld. Advocate for the accused person moves the petition submitting that accused Lakhindar Paloi could not come before this court. For that reason order of warrant of arrest was issued against the accused person on 13/02/2024. Previously accused person got bail on 07/08/2018. If accused person is released on bail he will come regularly before this court. There is no chance of absconsion. Accused person prays for bail on any condition.

Ld. PP-in-charge raises objection.

Heard both sides. Perused the case record. Considering submission of both sides it appears to me that previously accused person was on bail. It also appears that accused person has surrendered voluntarily before this court. Accordingly, prayer for bail of the accused person namely Lakhindar Paloi is allowed. Accused person namely Lakhindar Paloi may find bail bond of Rs. 1000/- with one registered surety except previous surety subject to satisfaction of Ld. ACJM, Jhargram and on condition that accused person will remain present before this Court on every date of the case and he will not tamper the evidence in any manner.

Let a copy of this order be sent to Ld. ACJM, Jhargram and I/C, Gopiballavpur PS for information and taking necessary action.
