On introspection of the case record, it appears that the instant case was originated on 21.05.2015. Charge was framed U/s-302/201 of I.P.C. against the accused person after due consideration of the materials on record for committing heinous crime of murder. Conflict regarding juvenility of the accused arose on 29.05.2017 when the accused filed a prisoner's petition and claimed himself a juvenile. To adjudicate the matter properly this Court examined Teacher-in-Charge of Rangamatia Junior High School and Teacher-in-Charge of Jamsola Primary School on 24.11.2017 and 30.01.2018 respectively and also perused the relevant documents produced by the said school authorities where the accused got admitted. But the documents failed to gain confidence of this Court to resolve the conflict of juvenility. Finally, this Court has to take resort of Ossification test for arriving to a just and proper conclusion. Accordingly, this Court directed the Superintendent of Jhargram District Hospital to hold the Ossification test of the accused Krishna Bhakta in pursuance of a speaking order dt. 20.02.2018. It is very significant to mention here that this Court has also issued two successive reminders to the concerned hospital authority for its compliance vide memo no.-62, dt.20.02.2018, memo no.-92, dt.20.03.2018, memo no.-126, dt.13.04.2018, but all are went in vain.

This Court is completely in dark whether the Ossification test of the accused was held or not as no communication has been made by the concerned authority till today. It is very regrettable and unfortunate to mention here that despite of receiving repeated directions issued by this Court, the Superintendent of concerned hospital remained silent and slept over the matter days together. It is the utmost duty of any authority of public concerned to comply the order of a Court of law in delivery of justice. Other wise this should be treated as gross violation of article-21 of our Constitution. It is also the bounden duty of this Court to facilitate speedy trial and to establish the rights of the individuals. The said conduct of the Supdt., being the head of the concerned hospital is neither acceptable nor applaudable and it is the high time to take immediate action for such type of misconduct which shows a clear obstacle/impediment as regards to the delivery of smooth dispensence of justice.
