**Order No. 61 Dated 29/08/2025.**

Today has been fixed for appearance of the accused persons and evidence of prosecution witnesses.

Ld. PP-in-charge and Ld. Advocate for the accused person are present.

Accused persons are present by taking steps.

One witness namely Mampi Biswas, LSI of Police, is present. After receipt of summons and step has been taken by prosecution on her behalf. It appears from the order No. 60 dated 13/08/2025 that Md. Golam Gasul, S.I. of Police, Jangipur Police District and Inspector Ramesh Saha prayed for time for their appearance. On previous occasion which was considered and allowed and Superintendent of Police, Jhargram was requested to ensure the presence of Inspector Ramesh Saha along with other witnesses today. The previous schedule was also cancelled on the prayer of Ld. Public Prosecutor, Jhargram. I would like to mention in this regard that on 15/11/2019 S.I. Ramesh Saha was examined-in-chief and his examination was deferred as because the seized articles were not produced before the Court as it appears from the deposition sheet. But today in spite of prayer of time by Inspector Ramesh Saha and Md. Golam Gasul, S.I. of Police, Jangipur Police District both and other did not turn up before the Court and no arrest was received from their behalf. On the other hand, LSI Mampi Biswas appeared today who is presently posted as Chandannagar Police Commissionerate as stated by her resulting into inconvenience to the witness and loss of judicial hour as because the above-named witnesses did not turn up. In this regard, the Court may presume that there is some miscommunication in between the monitoring cell and prosecution in bringing prosecution witnesses and for the same it is resulting into futile exercise.

Accordingly, Superintendent of Police, Jhargram is requested to kindly sensitize the Monitoring Cell through its Officer-in-charge of Jhargram Court so that no other inconvenience be caused to any of the police personnel and other witnesses regarding any miscommunication in between the stake-holders regarding production of witnesses and their examination.

A copy of this order be sent to Superintendent of Police of Jhargram, in the rank of DIG, and Additional Superintendent of Police (Head Quarter), Jhargram for their information.

Witness Mampi Biswas could not be examined for the above reason and discharged for this day.
