Today is fixed for production of accused person and consideration of charge.

Accused person Vikash Kumar is produced before this Court.

Ld. Special P.P. Subhasis Dwibedy is present. Ld. Advocate Ashoke Kumar Ganguly is present on behalf of accused person Vikash Kumar.

Ld. Special P.P. and Ld. Lawyer for the accused person submit that charge can be framed today as the accused person is present today.

Accordingly, case is taken up for consideration of charge under section 251 of the Cr.P.C. Heard both sides. Perused the materials on case record and Case Diary.

After consideration and hearing both sides, I am of the opinion that there is ground for presuming that the accused person namely Vikash Kumar committed offence punishable U/s. 06 of POCSO Act and U/s. 363/365/366/376(2)(n) of the IPC and U/s. 9 of the Prohibition of Child Marriage Act, 2006 which are exclusively triable by this court.

Accordingly, charge is framed in separate sheet against accused person namely Vikash Kumar U/s. 06 of POCSO Act and U/s. 363/365/366/376(2)(n) of the IPC and U/s. 9 of the Prohibition of Child Marriage Act, 2006 within the cognizance of this court which is kept with the case record.

Charge is read over and explained in vernacular to the accused person to which he pleads not guilty by saying "Ami nirdosh" and claims to be tried.

Issue summons accordingly upon all the Charge Sheet witnesses. Ld. Special P.P. to put-up summons at once for issuance to all the witnesses as per section 62 Cr.P.C. I.O. must be present on all days of the trial to ensure the presence of the witnesses according to schedule. I/C of Jhargram PS must ensure the presence of all the witnesses before this court in time and the alamat should be produced in court by the officer-in-charge of the concerned PS and Special P.P is to ask the I/C of the PS accordingly.

Let a copy of this order sheet be sent to the Officer in charge of Monitoring Cell of court cases for giving direction to the IO of this case for regular attendance of the witnesses and for taking necessary action so that the case is not delayed for non-attendance of the witnesses.

Fix 16/12/2024 and 17/12/2024 for evidence of CSWs and production of the accused person.
