Accused person has been produced through V.C. facility from the M.C.C Home, Paschim Medinipur.

Bail petition, filed by the D.L.S.A appointed Ld. Advocate, on behalf of the said accused person and prayed for P.R bond of the accused person as the accused person has no capability to furnish the bail bond.

Heard the Ld. Advocate, appearing on behalf of the accused person.

Perused the materials on record.

Perused the case record as well as the materials available therein. It transpires that on 02.09.2025 this Court has considered and allowed the bail application filed by the accused with bail bond of Rs. 1,000/- with one surety of like amount i/d to J/C. But since then the accused did not furnish any bail bond before this Court and remained in the J/C till date. Considering the present circumstances this Court is of the view to modify its earlier order dt. 02.09.2025 and allowed the prayer of accused person and released him on P.R bond.

Hence, the prayer of the bail petition of the accused person is considered and allowed on P.R bond of Rs. 1,000/-.

Seen the forwarding report, memo of arrest, inspection memo, seizure list, check list, information of arrest under section 48 (1) of BNSS, information of arrest under section 47 (1) of BNSS of accused namely Ansar Khan who is brought under arrest by Garhbeta P.S. and produced before this Court today. Accused person is taken into custody all documents are kept with the case record.

A bail petition is filed by the Ld. Advocate namely Arindam Singha Roy appointed by accused person namely Ansar Khan along with fresh vokalatnama and the Ld. Advocate of the accused submitted before this Court that the accused person has been falsely implicated and has no nexus with the alleged incident as nothing has been seized from the possession of the accused person by the police.

Ld. A.P.P. opposed the bail application.

Perused all the materials available on record.

Heard the Ld. A.P.P.

Heard and considered the submissions of both the sides.

Perused the case record as well as the materials available therein. It transpires from the case record one of the section is Sessions triable and the seizure list reflects 109 bags of ordinary sand has been seized by the I.O and except this nothing has been seized or recovered by the I.O. Though, the investigation is in nascent stage, by considering the stolen articles, recovered and seized by the I.O as alleged, in this circumstances I am inclined to allow the bail application of the accused person.

Thus, the accused person namely Ansar Khan may find bail upon furnishing bond of Rs. 2,000/- with two sureties of Rs. 1,000/- each i/d J/C.
