The case record is put up today on receipt of the same from the CSI, Cuttack.

Learned Advocate Sri R.K. Nayak and his associates files V. Nama in favour the accused person namely Sisir kumar Jena which is **accepted**. Accused person is present before the Court being indentified the Ld Counsel and files a petition to plead his guilty in the instant case. Perused the case record and founds that, this is a case U/s.281 of BNS and 181,185,177,196 of MV Act and same are triable by this Court and punishable with simple imprisonment, or with fine. The accused person has pleaded his guilty for the aforesaid offences and did not claim for trial and the same has been recorded vide separate sheet. The accused is found guilty for the offenses U/S.281 of BNS and Section-181,185,177,196 of MV Act.

Taking into account the facts and circumstances of the case, I am not inclined to extend beneficial provision of P.O. Act to the Accused Person. So far as the sentencing is concerned, taking in view that the offender being first time offender, I am of the opinion that instead of sentencing him for imprisonment, only imposition of fine as punishment will serve the purpose. Accordingly, the Convict is sentenced to pay fine of **Rs.400/-** (Rupees Five Hundred only) for the offence punishable U/S. 281 of BNS and in case of default, to undergo Simple Imprisonment (S.I.) for 15 days, **Rs.5000/-** (Rupees Five Thousand only) for the offence punishable U/S. 181 of BNS and in case of default, to undergo Simple Imprisonment (S.I.) for 30 days, and **Rs.10,000/-** (Rupees Ten Thousand only) for the offence punishable U/S. 185 of MV Act, **Rs.300/-** (Rupees three Hundred only) for the offence punishable U/S. 177 MV act and in case of default, to undergo Simple Imprisonment (S.I.) for 10 days, and **Rs.2000/-** (Rupees Two Thousand only) for the offence punishable U/S. 196 MV Act and in case of default, to undergo Simple Imprisonment (S.I.) for 15 days, Draw the fine cheque accordingly and put up later when fine is paid.
