Later Order dated 29.10.2024:

Today is fixed for production of accused Suresh Santra from P.C. along with C/D.

Accused is produced from P.C. along with a forwarding report and a prayer for adding Section 310(2) of BNS in this case.

Accused is taken into custody and documents are kept with the case record.

One bail petition along with vokalatnama is filed on behalf of the accused person. Let them be kept with the case record.

Now the bail prayer of accused **Suresh Santra** is now taken up for hearing.

Heard the Ld. Advocate appearing for accused person.

Perused the materials on record and forwarding report of the I/O.

The present case is registered under sections 303(2) of BNS and investigation is in early stage. Therefore, the bail prayer stands **rejected**.

Accused **Suresh Santra** is **remanded to J/C till 08.11.2024**.

One more accused person, namely **Nazrul Khan** is brought under arrest by the Garhbeta P.S. Police, produced before the Court today along with a forwarding letter, inspection memo and arrest memo of the accused person. Let the documents be kept with the case record.

I.O is also present along with C/D.

No bail petition filed on behalf of the arrested accused.

One application is made on behalf of the I.O. seeking five **(05)** days P.C. of the arrested accused person, **Nazrul Khan**. The prayer of the I.O. is duly forwarded by Dy.S.P (Operations), O/C Garhbeta P.S. and Circle Inspector, Paschim Medinipur.

The I/O has prayed for P.C. for newly apprehend accused persons. Hence, considering the materials available on record and the C/D, the P.C. prayer of the I/O is **allowed** for the benefit of investigation and recovery of stolen articles. Therefore, the P.C. prayer of I/O of accused person, namely, **Nazrul Khan is allowed but for three (03) days.**

During the period of police remand I/O is directed to get the accused person examined by M.O. of any Government Hospital or health centre after every 24 hours during period of police remand of the accused person and to comply the directives of the Hon'ble Apex Court and there should not be any custodial harassment caused upon the accused persons during the period of police remand.

Let a copy of this order be forwarded to the Ld. CJM, Paschim Medinipur for information.

Fix **01.11.2024** for return of the accused person from P.C. along with C/D, hearing of the prayer for adding Section 310(2) of BNS.

Return C/D.

Inform the I.O., APP and all concerned.
