Peruse the record and it transpires that till date summons of this Court has not served upon the defendants . According to the plaintiffs the disput between the plaintiffs and the defendants has been amicably settled and the plaintiffs are not willing to further proceed with the suit and P.W.1 and P.W.2 voluntarily said that they are not willing to proceed with the suit further as the dispute has been amicably settled between themselves. Hence ,it is

that the present suit **being no T.S. 70/25** be and the same is hereby **dismissed for non prosecution** by the plaintiffs without any liberty and without any any amount of cost or any claim .

Order No 87. Dated 21.01.2026

Today is fixed for argument by the plaintiff.

Both parties file their representative haziras through their Ld. Advocates.

Plaintiff filed one petition under section 142 and 143 of Bharatiya Sakshya Adhiniyam, 2023 with a prayer to recall the P.W. 1 to produce the present L.R. ROR of the suit property and the plaintiff also submitted that this fact has already been stated in the plaint and due to unavoidable circumstances these documents could not be filed on the relevant time and without this document the plaintiff will suffer loss .

The defendant raised strong objection against this recall of P.W. 1 application and the defendant did not file any written objection and submitted verbally that argument on the side of the defendant has already been completed and concluded and today is fixed for argument by the plaintiff and at this stage recall of the P.W. 1 may cause harm to the defence case and the defendant prayed for the rejection of the instant petition.

Heard & considered.

Peruse the case record and it transpires that defendant has concluded his argument on his part and today is fixed for the argument by the plaintiff. At this stage of argument plaintiff intended to recall the P.W. 1 to exhibit the L.R. ROR of the suit property. No doubt that plaintiff's cause delay to present his document before this Court and the plaintiff should file this document at the time of examination in chief of the P.W.1 and the defendant would also get the chance to cross examine the P.W. 1 upon this document. But this Court has pragmatic approach on this point as this document is a public document and this averment has already been made by the plaintiff in his plaint and moreover for the final determination adjudication of the suit all the documents of the parties need to be presented in this Court and for the ends of justice the plaintiff should get a fair chance to file this document for the complete adjudication of this suit. On the other hand, this Court opined that by filing this public document which are the L.R. ROR of the suit property, the defence case would not be hampered as this is a suit for eviction of tenants and the intended documents are relating to the L.R. ROR of the suit property. Hence, it is

ORDERED

the petition under section 142 and 143 of Bharatiya Sakshya Adhiniyam, 2023 dated 21.01.2026 filed by the plaintiff is hereby allowed on contest with a cost of Rs. 500/-, to be paid by the plaintiff to the defendant and the recall of the P.W.1 is allowed at the same time the defendant is allowed to cross examine the P.W.1 on recall as well as the defendant is also allowed to make argument on this point after completion of the argument of the plaintiff henceforth.

Plaintiff has paid the cost of Rs.500/- to the defendant and the Ld. Advocate of the defendant filed the receipt of the cost paid .
