Order dated 05.09.2024:

Today is fixed for appearance of I/O, appearance of all accused persons on C/B and further necessary order.

Ganesh Lohar 11. Ananta Lohar 12. Ashis Lohar 13. Sourav Mahanty 14. Mujibar Mallick 15. Tarun Ruidas** are on Court bail.

An Advocate haziran filed on behalf of the above named accused persons namely **1. Tushar Kanti Panda 2. Aktar Ali Khan 3. Mujibar Mallick** and **all the rest 12 accused persons** are present before the Court by filing haziran through Id. Advocate. Let the hazirans be kept with the case record.

No step taken on behalf of rest one C/B accused person namely **Ali Gazi** in spite of direction given on several dates upon the surety for ensuring appearance of the said accused before the Court, but, the accused did not turn up before this court even today. However, D.A. is failed to inform the Court's order to the concerned surety namely Debasrita Addhya because of being unable to contact with her and, moreover, she is presently not a registered surety of this Court.

Hence, issue **W/A against accused Ali Gaji.**

Seen the report from the Dy. S.P. (HQ), Malda, Camp at ratua, Malda is received through G-mail wherein he prayed for fixing another date for appearance of the I/O, namely SI Sujan Roy before this Court on the ground as stated therein.

Perused the copies of G-mail reports. The prayer for time is considered and **allowed.**

Hence, the I/O namely SI Sujan Roy of the present case is directed to appear personally and submit a written explanation clarifying the actual identity and address of accused Alauddin Mallick named by him in the Charge Sheet as Charge Sheeted accused number 13 in this case, positively, on the next fixed date.

To **27.11.2024** for appearance of the I/O, appearance of all C/B accused persons, E/R of W/A against accused Ali Gaji and further necessary order.

Let a copy of this Order be forwarded to the Dy. S.P.(HQ), Malda, cantt at Ratua, Malda for his information and taking necessary action for ensuring compliance of Court's Order by the I/O.
