Brief particulars of the petition:

This Petition is filed by the Petitioner against Respondents claiming compensation for the injuries sustained by him due to the accident caused by the 1st Respondent.

This Petition was referred to the Lok Adalat at the request of both parties /on memo filed by the Advocate for the Petitioner by the motor Accidents claims Tribunal cum SC & ST Cum 11th Additional district judge At Visakhapatnam.

This Petition is coming today on 16-3-2024 for final settlement in the Presence of Petitioner and the Respondent No 3 B.Rama Gopala Raju, Ch: Geetha Advocates for Petitioner and B.Manjula Advocate for the 3RD Respondent Hence the following Award is passed as per the settlement arrived by the Parties.

AWARD UNDER SECTION 21 OF THE LEGAL SERVICES AUTHORITY ACT 1987

1. Petitioner and Authorized Officer of Respondent No 3 present and that the matter is settled for a sum of Rs 5,15,000/- Rupees (Five Lakhs fifteen thousand only) towards full and final settlement of the claim without interest and costs.
2. The Lok Adalat Bench satisfied, thus passed the Award accordingly U/s.21 of the Legal Services Authority Act, 1987 and the Compensation amount to be deposited within one month from the date of Award.
3. If the Respondent No 3 does not deposit the above amount within one month from the date of the Award, the amount so Awarded shall carry interest at the rate of 7.5% per annum from the date of the Award.
- 4) on deposit of compensation amount Petitioner is permitted to withdraw his entire compensation amount of Rs 5,15,000/- Rupees (Five Lakhs fifteen thousand only)
- 5) The Claimant/Petitioner shall file their attested copies of Passbook of Nationalized Bank, for depositing the permitted withdrawal of Compensation as in Point No.4 amount by the Insurance Companies/Other parties, who are liable to

pay the compensation, directly to pay the Award amount in the respective accounts by NEFT/RTGS in terms of the directions of Hon'ble Supreme Court of India in "Bajaj Allianz General Insurance Company Pvt. Ltd. Vs. Union Bank of India & Others".

6). In case of non-furnishing of attested copies of Passbook of Nationalized Banks as in Point No.5, the Insurance Company/Other parties, who are liable to pay compensation amount which is ordered to be paid to the parties as in Point No.4, shall deposit in Savings Bank A/c.No.0462001700005601, IFSC Code PUNB0046200, MICR Code:530024001 of Punjab National Bank, LIC Building Branch, Visakhapatnam in the name of Chairman, Motor Accident Claims Tribunal, Visakhapatnam as to pay to the parties as per the Award.

7). The settlement between Petitioner and Respondent No 3 shall be without prejudice to absentee parties contentions, and claim against absentee parties shall stand NOT-PRESSED.

The Court Fee paid, shall be refunded under Section 21(1) r/w. Section 25 of the Legal Services Authorities Act, 1987.

Both parties have affixed their signatures in evidence of their consent for the terms of award.
