Today is fixed for evidence of C.S.W-6,7 ,8 & 10.

All 3 accused persons on court bail are present by filing hazira.

Ld.PP in charge produced 4 witnesses but subsequently not tendered witness Sadikul Mia.

The remaining witnesses namely, Munmun Khatun Bibi, Moktarul Mia @ Moktar Hossain Mondal and IO Sanjib Bhadra, S.I were examined in chief and cross examined in full as PW-5 ,P.W-6 and P.W-7 respectively before being discharged.

On the basis of their evidence, the formal FIR, endorsement made by the O/C of concerned P.S on written complaint, rough sketch map of the PO along with index thereof & seizure list prepared by the P.W-7 were marked as exhibits-3,1/2,4, 4/1 & 2 respectively as per the deposition sheet and exhibit list.
