On the other hand, learned counsel for the petitioners submits that the petitioners herein are not involved in the commission of offence and in support of his contention he got a pen drive containing video of the incident and a copy of the said pen drive is handed over to the learned Assistant Public Prosecutor before this Court, to verify the same.

In view of the aforesaid facts and circumstances and also due to paucity of time, this Court could not take up the matter for hearing. Instead of simply adjourning the matter, this Court directs the police concerned not to take any coercive steps as against the petitioners herein.
