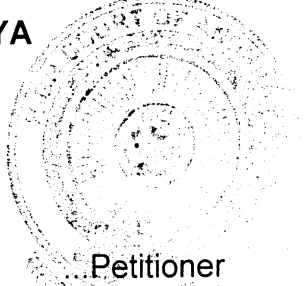

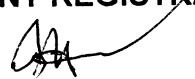
ORDER:
