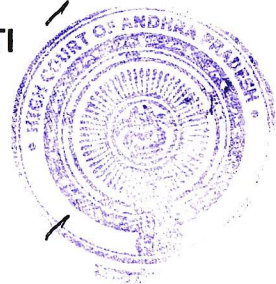

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the operation of decree and order dated 16.09.2025 in D.O.P.No.63 of 2020 on the file of III Additional District Judge, Buimavaram, West Godavari District, pending disposal of CMA No. 150 of 2026, on the file of the High Court.

**The Court made the following order:**

**“This appeal has been filed by the wife, being aggrieved from the decree of divorce in the petition filed by the respondent/husband under Section 27(1)(b)(d) of the Special Marriage Act, 1954.**

**2. Issue notice to the respondent.**

**3. In addition to the normal mode of service, the appellant is permitted to take out personal notice by Registered Post with Acknowledgement Due and file proof of service by the next date.**

**4. List on 27.04.2026.**

**5. Considering the submissions advanced as also the consequences vide from the divorce decree, we stay operation of the decree of divorce and the parties shall not remarry, till the next date of listing.**

**6. After the appearance of the respondent, the Court would consider to refer the parties for mediation.”**
