WHEREAS the said case coming on for hearing on this day and whereas the High Court upon perusing the affidavit filed herein and the earlier order of High Court dated 30.01.2026 made herein and upon hearing the arguments of Sri K.P.S.Sailesh Reddy, Advocate for the Petitioner and of Sri Daddu Nava Kiran, learned Counsel appearing on behalf of Sri Gurram Ramachandra Rao, Advocate for Respondent Nos.1, 2 and 4, directed the Registry to issue **Bailable Warrant to Respondent No.5.**

Therefore, you viz;

The Superintendent of Police, Eluru District at Eluru.

are hereby directed to arrest the said respondent No.5 viz; Nimmagadda Raveendra Bharathi, Deputy Educational Officer, Bhimadole, Eluru, Eluru District, wherever she is found and produce her bodily under safe custody and conduct before this Court on 21.04.2026 at 10:30 A.M., to which date the case stands posted.

You are further directed that if the said respondent furnishes personal bond for a sum of Rs. 10,000/- (Rupees Ten thousand only) with two sureties each for a like sum with an undertaking affidavit that she will appear before this Court on 21.04.2026, she may be released on bail subject to the condition that she shall attend this Court on 21.04.2026 and shall continue to attend this Court until otherwise directed.

You are also further directed to return this warrant as early as possible preferably on or before 21.04.2026 to this Court with a detailed report stating the manner in which it has been executed.

Herein fail not.

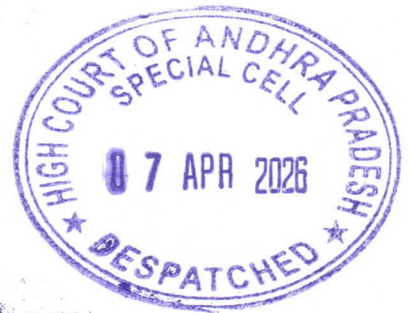
