The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Raja Manuri Venkata Sumanth, Advocate for the Petitioner, and of Public Prosecutor for the Respondent No.1, the Court made the following.

ORDER

Heard the learned Counsel for the Petitioner.

At the request of the learned Assistant Government Pleader, list the matter on 22.04.2026.

The learned Counsel for the Petitioner submits that the earlier Investigating Officer had concluded that no case was made out against the Petitioner, whereas the subsequent Investigating Officer has again indicted the Petitioner.

In view of the above, the Investigating Officer, CID, Amaravati, shall appear before this Court along with the record on 22.04.2026.

Until then, the Investigating Officer shall not take any coercive steps against the Petitioner.
