

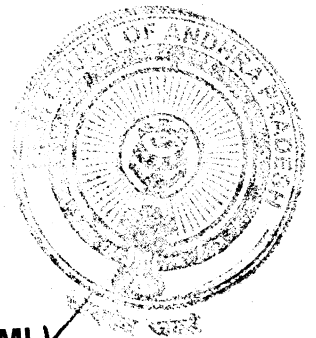

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ and Order or Direction more particularly one in the nature of Writ of Mandamus declare the action of the respondents, particularly the 2nd respondent in passing Impugned Order in Appeal Petition No.CS3/225/2020 dated 15.10.2020 upholding the Orders issued by the respondents No.3 and 4 i.e. canceling and suspending the dealership of the petitioner to the Fair Price Shop No.1325011 of Pedda Horthur Village, Alur Mandal, Kurnool District as illegal, arbitrary, improper, unjust, contrary to provisions under Andhra Pradesh State Targeted Public Distribution System (Control) Order, 2018 and in violation of principles of natural justice guaranteed under Article 14 and 16 of the Constitution of India and consequently set-aside impugned Order in Appeal Petition No.CS3/225/2020 dated 15.10.2020, direct the respondents to continue the petitioner as Dealer of Fair Price Shop No.1325011 of Pedda Horthur Village, Alur Mandal, Kurnool District.

IA NO: 1 OF 2021

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to continue the petitioner as Dealer of Fair Price Shop No.1325011 of Pedda Horthur Village, Alur Mandal, Kurnool District by suspending the Order in Appeal Petition No.CS3/225/2020 dated 15.10.2020, which was issued by the 2nd respondent, pending disposal of WP No. 2240 of 2021, on the file of the High Court.

The petition/Appeal coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court order dated 03-02-2021 made herein and upon hearing the arguments of Smt Sushma Yaganti, Advocate for the Petitioner and GP for Civil Supplies for the Respondent Nos. 1 to 3 and GP for Revenue for the Respondent Nos. 4 & 5, the Court made the following.
