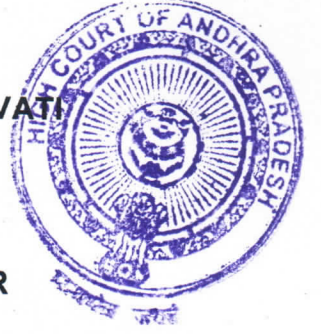

WHEREAS the Petitioner above named through its Advocate Sri Karthik Ramana Puttamreddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Certiorari or any other appropriate writ or order or direction quashing the impugned order of the 1st Respondent in Rc.No.226/1996 A4, dated 20.10.2021 as illegal, arbitrary without jurisdiction and unsustainable on merits and consequently declare the sale transaction effected by the 3rd Respondent to the Petitioner, vide Sale Deed No.2195 of 2021, dated 30.3.2021 before Sub-Registrar office, Vizianagaram as valid and legal transaction and not hit by the provisions of Section 27(1) of the APVAT Act, 2005.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Karthik Ramana Puttamreddy Advocate for the Petitioner, directed issue of notice to the Respondent Nos.2 & 3 herein to show cause as to why this WRIT PETITION should not be admitted.
