ORDER:

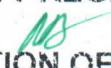

Having regard to the fact that this Court had passed an Order in the Writ Petition No.18076 of 2024 on 15.10.2025, granting three months' time for clearance of the amount claimed by the Petitioner for an amount of Rs.20,05,356/-, and since the Petitioner is once again compelled to approach this Court by filing the present Contempt Case due to non compliance of the Order of this Court, this Court is inclined to issue Form I Notice to the Respondents.
