Let an affidavit be filed along with relevant material by the date of next adjournment.

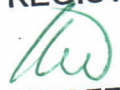

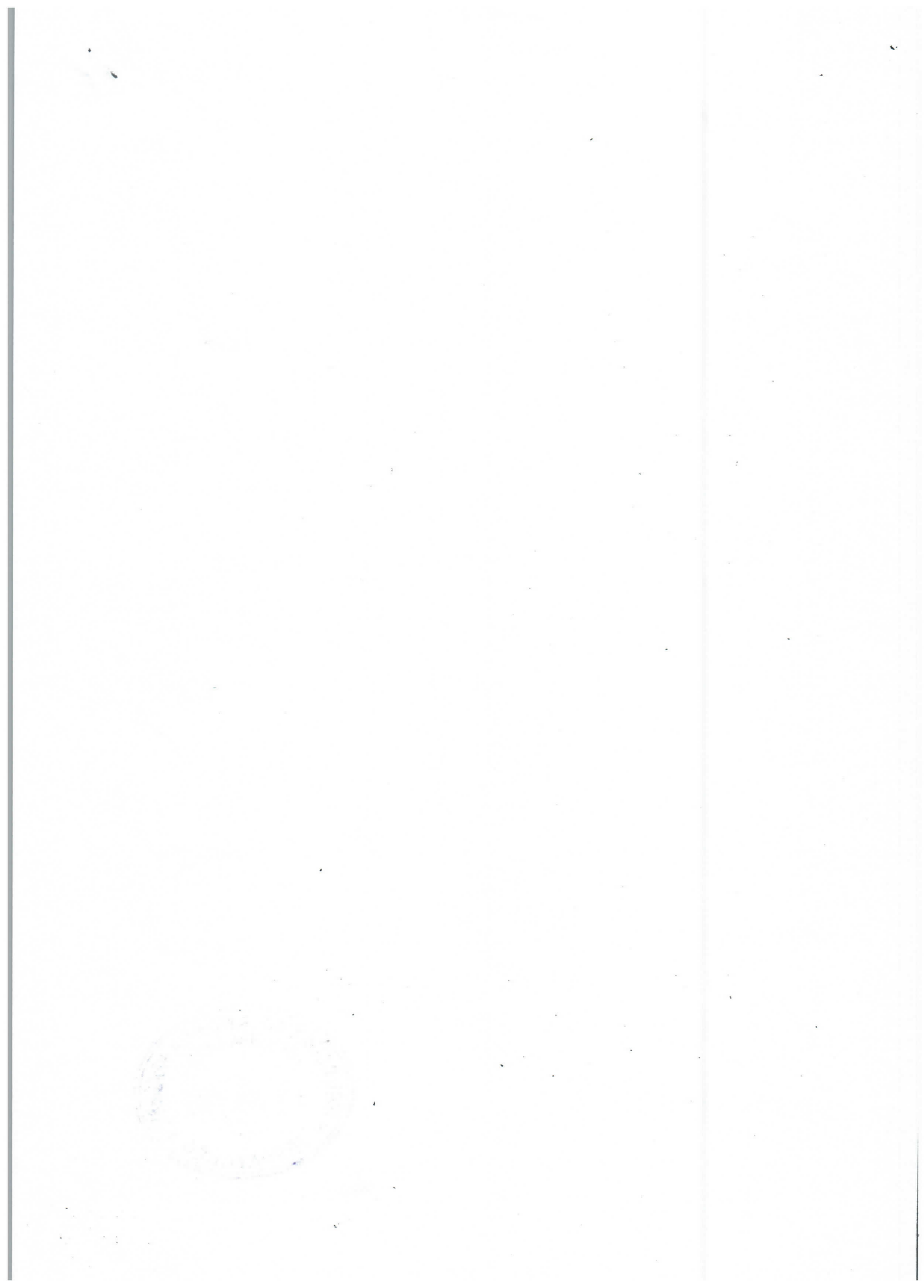
