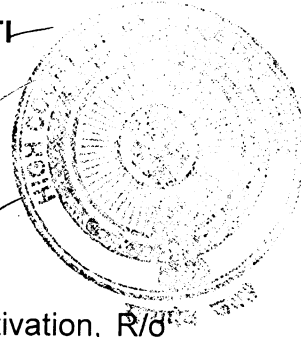

Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of respondents, particularly the 5th respondent in insisting petitioner to vacate from his house and site property admeasuring Ac.0.05 Cents in Sy.No.656 of Bapatla East (U) Town and Mandal in Guntur District, belonged to the 5<sup>th</sup> respondent Choultry, as illegal, irregular, irrational without jurisdiction, violative of the provisions of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 and rules framed there under, and offends Articles 14, 21 and 300-A of Constitution of India and consequently direct the respondents particularly the 5th respondent not to interfere with petitioner's possession over the said house and site property.

**IA NO: 1 OF 2021**

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents particularly the 5<sup>th</sup> respondent not to interfere with petitioner's possession over his house and site property admeasuring Ac.0.05 Cents in Sy.No.656 of Bapatla East (U) Town and Mandal in Guntur District, belonged to the 5<sup>th</sup> respondent Choultry, pending disposal of WP No. 4086 of 2021, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court order dated 19-02-2021 made herein and upon hearing the arguments of M/s. Nimmagadda Revathi, Advocate for the Petitioner, GP for Endowments for Respondent No.1 to 4 and of Sri K Madhava Reddy, Standing Counsel for Respondent No.5, the Court made the following.

**ORDER**
