Presence of petitioner Nos.2 & 3 i.e., A2 & A3 before the trial Court is dispensed with except Petitioner No.1/Accused No.1, excluding on those dates when the learned Magistrate feels that the presence of petitioner Nos. 2 & 3 i.e., A2 & A3 is necessary.

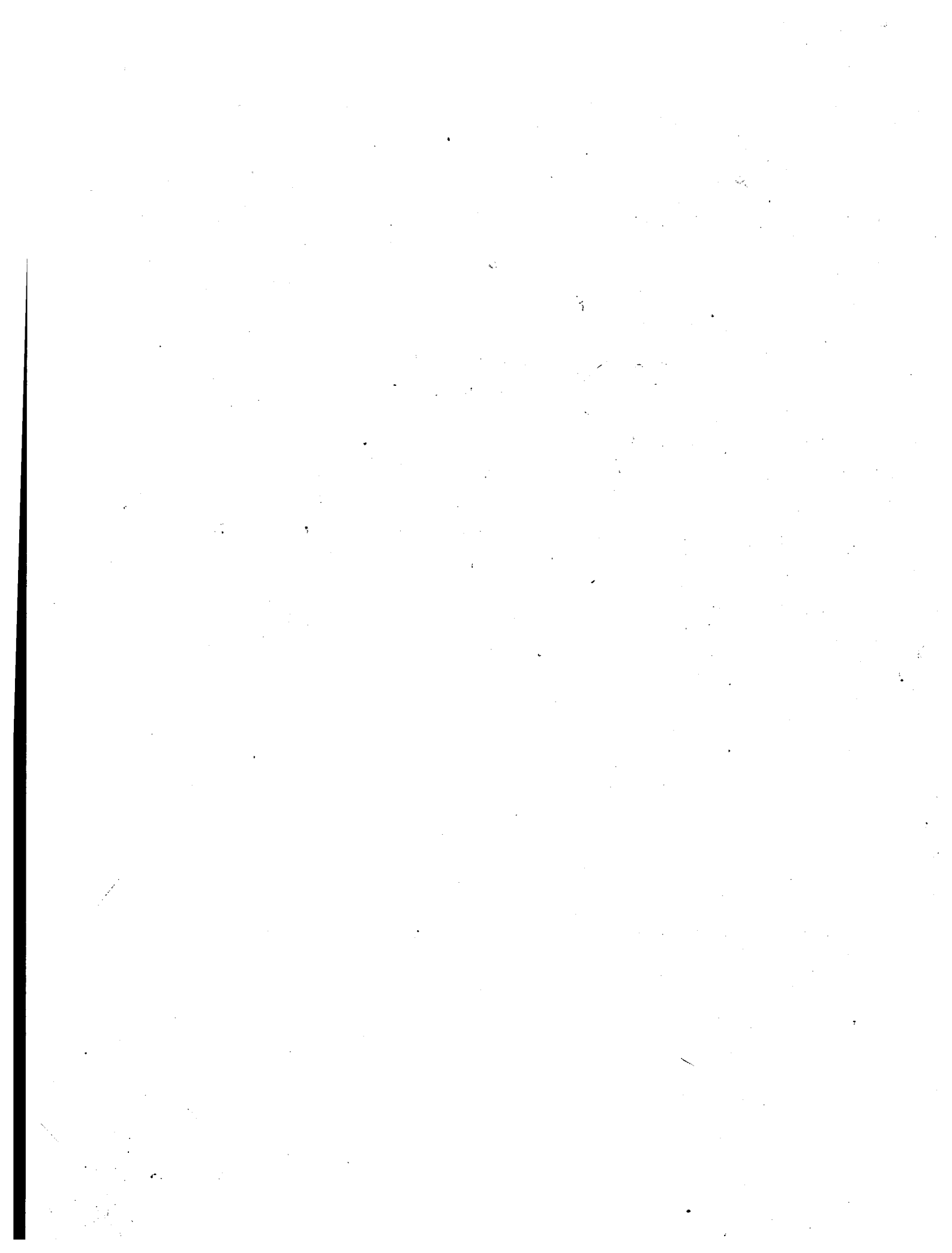
